**ORDER APPROVING  
SUPPLEMENTAL NOTICE  
OF HEARING FOR COURT  
APPROVAL OF  
SETTLEMENT, CLAIMS  
BAR & INJUNCTION**

The Motion for Approval of the form and manner of Supplemental Notice is before the Court and;

By order dated May 13, 2002 this Court approved the Notice of Hearing for Court Approval of Settlement, Claims Bar and Injunction submitted by the plaintiffs;

On May 31, 2002 Plaintiffs reached settlements pending approval of the Court and issuance of a claims bar by this Court following a mediation with Deloitte & Touche LLP and PriceWaterhouseCoopers LLP;

The parties have proposed the settlements of the claims against Deloitte & Touche LLP and PriceWaterhouseCoopers LLP, the terms of which are embodied in settlement agreements to be filed forthwith;

1 Notice of the Hearing on the settlements with Deloitte & Touche  
2 I LP and PriceWaterhouseCoopers LLP should be given to all plaintiffs,  
3 defendants, settling parties, creditors and clients of CCL, parties having filed  
4 proofs of claims, and other interested persons;

5 IT IS HEREBY ORDERED:

6 The Court approves the form of Supplemental Notice of Hearing  
7 for Court Approval of Settlement, Claims Bar & Injunction filed herewith.

8 On or before June 7, 2002, the Plaintiffs shall cause to be mailed  
9 by first class mail the Supplemental Notice of Settlement and Claims Bar to  
10 all plaintiffs, defendants, settling parties, creditors and clients of CCL,  
11 parties having filed proofs of claim and other interested persons.

12 On or before June 18, 2002 the parties, or any mailing service  
13 they employ, shall serve and file a certificate evidencing compliance with the  
14 mailing of the Notice as described herein;

15 No person shall be heard in opposition to the settlement and  
16 claims bar or, if approved, the judgments or other orders to be entered  
17 thereon, unless on or before June 14, 2002 such person has filed with the  
18 Court and copied to the Receiver, counsel to the Hazzard plaintiffs, counsel  
19 to Deloitte & Touche LLP, and counsel to PricewaterhouseCoopers LLP, as  
20 identified in the Supplemental Notice, any objections.

21 The Hearing shall be held before the undersigned at 9:00 a.m. on  
22 June 19, 2002 (U.S. Courthouse, 1000 SW Third Avenue, Portland, Oregon  
23 97204).

24 The Receiver shall not file opposition to the proposed settlements  
25 with Deloitte & Touche LLP and PricewaterhouseCoopers LLP, and shall not  
26 file or post on the website any report on the proposed settlements unless and

1 until approved by the Court.

2 The Court may continue the Hearing from time to time without  
3 further notice.

4 IT IS SO ORDERED.
